州長 CUOMO 宣佈財產稅減稅計畫得到超過 225 位地方當選官員的支援

Suffolk 郡郡長 Steve Bellone 支援財產稅改革提案

州長 Andrew M. Cuomo 今日宣佈其旨在降低財產稅的計畫得到了超過 225 位地方當選官員的支援。

「財產稅是紐約州民眾最沉重的單項財務負擔之一，而我們不能再讓我們作為全國稅務之都的不良聲譽傷害到我們的廣大房主，」州長 Cuomo 說。「隨著我們已剛剛努力精簡了州政府並控制住我們的財政，地方政府必須繼續做同樣的事。我們的財產稅改革工作計畫可減稅超過 10 億美元，同時可鼓勵地方政府透過合作來共用服務，從而為十分臃腫的官僚機構「瘦身」。對我們計畫的支援聲浪日益高漲，我感謝地方領袖和無數的紐約州民眾大聲呼籲立法會讓財產稅改革成為現實，從而表達其支援立場。」

Suffolk 郡郡長 Steve Bellone 說：「過去三年裡，州長 Cuomo 已證明自己是 Suffolk 郡忠實的合作夥伴。他認識到高企的財產稅會給房主造成沉重負擔，並意識到我們需繼續吸引新企業進駐我們地區。其州情諮文中的工作計畫將會解決該問題，並繼續推動紐約州走上經濟增長之路。從減稅到激動人心的教育系統提案，再到 Sandy 後的社區重建，州長今年的工作日程中滿是前景光明的好計畫。我十分讚賞他的高瞻遠矚，並會不遺餘力地推進其願景的實現。」

Suffolk 郡立法會主持官員 DuWayne Gregory 說：「我讚賞州長 Cuomo 凍結財產稅兩年的提案。財產稅凍結不僅能夠為州居民節省下大量的稅金，而且能夠成為強大的工具來吸引新企業進駐本州並創造就業。Suffolk 郡立法會深知減輕財產稅負擔的重要性，因此在過去 11 年裡，我們從未提高過 Suffolk 郡的普通基金財產稅，甚至曾降低了普通基金財產稅。」

州長之計畫會為那些採取措施來合併和共用服務之地方政府中的社區提供兩年的財產稅凍結，並會依據個人房主之支付能力來提供減稅。在實施州長財產稅凍結提議的第二年間，約 700,000 名長島房主可共節省高達 3.94 億美元，人均減負 565 美元。依據斷路器(Circuit Breaker)提議，約 367,700 戶家庭將有資格享受平均 755 美元的房產個人所得稅稅收抵免，並總共為長島居民節省 2.78 億美元。

凍結財產稅

財產稅凍結是一項兩年期提議，旨在激勵地方政府共用服務及減輕納稅人的財務負擔。如紐約州民眾所在的地方政府採取了財產稅上限，則他們將會有資格於第一年享受財產稅優惠。第二年間，如紐約州民眾所在的地方政府繼續採取財產稅上限，並腳踏實地地尋求合併和共用服務並最終降低開支，則凍結政策將會繼續為他們減輕稅負。全面落實後，凍結政策可為地方政府和學區帶來最高 10 億美元的減稅，為多達 280 萬納稅人平均減負 354 美元。

基於支付能力實施「斷路器」

目前，多達二百萬的紐約州中低收入納稅人會對於超過其所得稅率之收入繳納有效不動產稅率。州長的斷路器提議會制定一項逐步實施的稅收抵免，以依據個人房主之支付能力提供稅收優惠。全面落實後，斷路器政策可為約兩百萬紐約州民眾平均減負 500 美元。

啟動「無藉口」計畫

僅僅兩週前，州長啟動了「無藉口」(No Excuses)推進計畫，以幫助通過其提議的財產稅削減提案。該計畫推出一個網站(<http://cutpropertytaxes.ny.gov/>)，其中包含來自當選官員、倡導團體及負擔高稅率之房主的支援言辭。另外，州長敦促紐約州民眾積極聯絡其立法委員以發出自己的呼聲。按一下[這裡](#)觀看標誌著啟動「無藉口」計畫的視訊（對於電視臺，可於[這裡](#)下載高清版）。
