**GOUVÈNÈ CUOMO ANONSE YON DEZYÈM SERI SIBVANSYON POU
KONSTRIKSYON INITE LOJMAN SIPÈVIZE TOUPATOU
NAN ETA NEW YORK**

***Gwo plan sou 5 an ki koute 2.6 milya dola Gouvènè a mete sou pye a pou bati
6,000 inite lojman sipèvize ap kontinye vanse***

***169 founisè nan kominote a nan 47 konte ap fè konpetisyon pou resevwa jiska 30
milyon dola chak ane pou sèvis nan kad sibvansyon kondisyonèl sa yo***

Jodi a, Gouvènè Andrew M. Cuomo te anonse 169 sibvansyon kondisyonèl bay òganis nan 47 konte toupatou nan New York ki pral ofri sèvis soutyen ak fon administrasyon pou omwen 1,200 inite lojman sipèvize pou moun ki pa gen kay epi ki gen bezwen espesyal, pwoblèm sante oswa lòt difikilte. Sibvansyon yo, ki bay yon total jiska 30 milyon dola, fè pati plan 2.6 milya dola sou 5 an Gouvènè a mete sou pye pou bati 6,000 inite Lojman Sipèvize.

“Sibvansyon sa yo pral ranfòse plis toujou efò nou yo pou lite kont absans domisil epi pèmèt Nouyòkè ki gen plis danje viktim yo nan tout kwen eta sa a jwenn lojman an sekirite, bon mache avèk sèvis soutyen yo bezwen yo”, **Gouvènè Cuomo te deklare.** “Avèk dezyèm seri sibvansyon an, n ap ede garanti tout Nouyòkè yo gen lojman estab ak yon opòtinite mennen vi toutafè satisfèzan ak pwodiktif.”

Yo te bay demandè yo enstriksyon demontre kijan pwopozisyon yo ta pral ede popilasyon espesifik yo sible pou bay soutyen yo, tankou paregzanp veteran, viktim vyolans familyal, vye granmoun frajil oswa andikape, jèn granmoun ki te nan prizon, ki pa gen kay oswa ki te nan fanmi dakèy, moun ak fanmi ki gen pwoblèm sanzabri kwonik, epitou moun ki gen pwoblèm sante, mantal ak/oswa ki soufri toksikomani.

Sibvansyon kondisyonèl yo se pou sèvis ak fon administrasyon ki nesèsè pou fè fonksyone inite lojman sipèvize pèmanan. Sibvansyon yo pral pèmèt demandè yo jwenn fon kapital apa pou finanse devlopman ak konstriksyon pwojè lojman yo an.

Sibvansyon yo anonse jodi a gen dwa sèvi pou ofri popilasyon sib ki kalifye yo asistans pou lwaye ak sèvis pou garanti yo gen lojman estab, tankou paregzanp:

- Sèvis swen sante primè ak konpòtman yo;

- Fòmasyon ak/oswa asistans pwofesyonèl ak pou anplwa;
- Asistans Edikasyonèl, ki gen la sipò pou GED;
- Devlopman ak sipò pou konpetans parantal;
- Asistans swen pou timoun;
- Konsèy sikolojik ak entèvansyon kriz;
- Sèvis pou timoun, ki gen ladan defans edikasyon sipò ak konsèy sikolojik; ak
- Sèvis oswa pèsònèl pou idantifye ak jwenn moun ki elijib ki bezwen lojman yo.

Senatè Betty Little, Prezidan, Komite Sena a sou Lojman, Konstriksyon ak Devlopman Kominotè (Senate Committee on Housing, Construction and Community Development) te deklare, “Lojman san danje, konvnan ak bon mache se yon bagay ki fondamantal pou otonomi. Sepandan, pou popilasyon nou yo ki gen plis danje pou yo viktim yo, sèvis soutyen yo se souvan kle ki pèmèt yo kenbe lojman sa a. Sibvansyon sa yo mete an priorite sèvis kowòdone nan kad solisyon lojman bon mache a, nan ede rezidan yo jere pwoblèm fizik ak mantal kwonik. Se yon viktim pou lojman bon mache, swen sante ak sa ki pi enpòtan an, Nouyòkè k ap gen yon kote yo kapab rele lakay yo.”

Manm Asanble Steven Cymbrowitz, ki se Prezidan Komite Lojman Asanble a (Assembly Housing Committee), te di, “Sibvansyon sa yo nan sant angajman Eta nou an pou li ofri lojman bay rezidan nou yo ki pi an danje pou yo viktim epi ki san sa ta kapab rete nan lari. Inite lojman sipèvize sa yo pral ede lite kont absans domisil epi estabilize lavi moun ki bezwen soutyen nou yon fason presan.”

Senatè Robert G. Ortt, Prezidan Komite Sena a sou Sante Mantal ak Andikap Devlopman (Senate Committee on Mental Health and Developmental Disabilities) te deklare, “Lojman estab se yon etap enpòtan nan direksyon endepandans pou moun nan kominote nou an ki pi an danje pou yo viktim. Ofri soutyen pou veteran yo, moun ki gen andikap fizik ak devlopman yo, ak viktim vyolans yo se yon efò enpòtan, epi lè lojman vin pi aksesib sa pral pèmèt plizyè milye Nouyòkè kontribye plis nan kominote yo epi bati yon avni pi bèl.”

Manm Asanble Michael G. DenDekker, Prezidan, Komite Asanble a sou Zafè Veteran (Assembly Committee on Veterans’ Affairs) te deklare, “Plan Gouvènè Cuomo a pou lojman sipèvize se egzakteman sa Eta New York la bezwen. Lè sèvis dirèk yo enkòpore nan inite lojman yo se sa ki pi bon pou vye granmoun yo, veteran yo, ak rezidan ki gen pwoblèm toksikomani ak diferan pwoblèm mantal yo epitou Nouyòkè ki gen plis danje pou yo viktim yo ak sa ki pa gen kay yo”.

Senatè George Amedore, ki se Prezidan Komite Pèmanan sou Alkolis ak Toksikomani nan Sena a (Senate Standing Committee on Alcoholism and Substance Abuse), te deklare, “Lojman sipèvize reyisi pou anpil moun ki simonte akoutimans. Finansman sa a pral garanti manm sosyete nou an ki gen plis danje pou yo viktim nan kominote toupatou nan eta a kapab jwenn soutyen ak sèvis yo bezwen yo pou kenbe yo sou chimen gerizon.”
