1 Section 1. The election law is amended by adding a new section 14-117
2 to read as follows:

3 § 14-117. Political contributions by limited liability companies or
4 other corporate entities. 1. No limited liability company or other
5 corporate entity doing business in this state, shall directly or indi-
6 rectly pay or use or offer, consent or agree to pay or use any money or
7 property for or in aid of any political party, committee or organization
8 organized or maintained for, or in aid of, any candidate for the offices
9 of governor, state assembly member or state senator, or for nomination
10 for such offices, or for, or in aid of, any corporation, joint-stock or
11 other association organized or maintained for, or in aid of, any candi-
12 date for the offices of governor, state assembly member or state
13 senator, or for nomination for such offices, or for the reimbursement or
14 indemnification of any person for moneys or property so used. Any offi-
15 cer, director, stock-holder, member, owner, attorney or agent of any
16 limited liability company or other corporate entity which violates any
17 of the provisions of this section, who participates in, aids, abets, or
18 advises or consents to any such violations, and any person who solicits
19 or knowingly receives any money or property in violation of this section
20 shall be guilty of a misdemeanor.

21 2. Notwithstanding the provisions of subdivision one of this section,
22 any limited liability company or other corporate entity or an organiza-
23 tion financially supported in whole or in part, by such limited liabil-
24 ity company or other corporate entity may make expenditures, including
25 contributions, not otherwise prohibited by law, for any candidate for
26 the offices of governor, state assembly member or state senator, or for
27 nomination for such offices, in an amount not to exceed five thousand
28 dollars in the aggregate in any calendar year.

1 3. Each limited liability company or other corporate entity that makes
2 an expenditure pursuant to this section shall file with the state board
3 of elections, by December thirty-first of the year in which the expendi-
4 ture is made, on the form prescribed by the state board of elections,
5 the identity of all direct and indirect owners of the membership inter-
6 ests in the limited liability company or other corporate entity and the
7 proportion of each direct or indirect member's ownership interest in the
8 limited liability company or other corporate entity.

9 § 2. Section 14-120 of the election law is amended by adding a new
10 subdivision 3 to read as follows:

11 3. (a) Notwithstanding any law to the contrary, all contributions made
12 to a campaign or political committee pursuant to section 14-117 of this
13 article, shall be treated as an individual contribution made by each
14 member of the limited liability company or other corporate entity in
15 proportion to the member's ownership interest in the limited liability
16 company or other corporate entity.

17 (b) If, by application of paragraph (a) of this subdivision, a
18 campaign contribution is treated as an individual contribution made by a
19 limited liability company or other corporate entity, such contribution
20 shall be further treated as an individual contribution made by each
21 member of the limited liability company or other corporate entity in
22 proportion to the member's ownership interest in the limited liability
23 company or other corporate entity.

24 (c) The state board of elections shall enact regulations that prevent
25 the avoidance of the rules set forth in paragraphs (a) and (b) of this
26 subdivision.

27 § 3. This act shall take effect immediately.
