

## **Gun Involved Violence Elimination (GIVE) Initiative Funding: July 1, 2024 – June 30, 2025**

*The FY25 Enacted Budget includes \$36,199,999 for the state's Gun Involved Violence Elimination (GIVE) initiative, with the state Division of Criminal Justice Services awarding \$35,937,910 in grants. The \$262,089 remaining is available to fund emerging issues identified by participating agencies. Funding for participating counties and agencies by region:*
