## 2024 MWBE Annual Report

### **Letter from the Executive Vice President & Executive Director of the Division of Minority & Women's Business Development**

For over 35 years, the New York State Division of Minority and Women's Business Development (DMWBD) has promoted greater participation in New York State contracts for NYS MWBEs. Our goal is to create an economic ecosystem that builds pathways for the historically underrepresented and taps into the limitless potential of the MWBE community.

In New York, MWBEs earn less wages and business earnings than their non-minority male counterparts. This is confirmed by the Empire State Development 2024 Disparity Study, which shows overwhelming evidence of disparities and MWBE underutilization in the private sector. The substantial evidence of disparity further supports the notion that, while the MWBE program has made effective steps to encourage equality of economic opportunities for MWBEs, it is vital for the program to continue its commitment to the MWBE community in eliminating barriers to their participation in state contracting.

Yet, despite the unique challenges, we have made significant strides over the last year. Below are some of our most memorable milestones:

**New York Continues to Lead the Nation in MWBE Utilization.** New York State not only met its nation-leading 30 percent MWBE utilization goal for the fourth year in a row but boasts a 32.21% MWBE utilization rate for FY 2023-24, representing \$2.8 billion. This is the second highest MWBE utilization rate in the history of New York State representing a \$144 million increase over the previous year. In fact, since Governor Kathy Hochul assumed office in 2021, nearly \$12 billion in state procurement has gone to MWBEs.

**Completed the Empire State Development 2024 Disparity Study:** In August, we released the results of ESD's 2024 Disparity Study. The purpose of the disparity study is to determine if there is a legally justifiable need for New York State's MWBE program to persist. The study provides undeniable evidence of widespread disparities in MWBE procurement in the private sector. It also gives New York State a compelling interest in continuing its MWBE program. **More Improvements to the Certification Process:** Following last year's historic elimination of the NYS MWBE Certification Backlog, DMWBD has continued, under the Governor's leadership, to improve the expediency and thoroughness of the certification process. In 2024, the average review time for a certification application process was less than 65 days - representing an 87% reduction in wait time over the last 3 years. We've also certified, and recertified, a record 2,100 MWBEs, and counting, just this year alone. Finally, with the multitude of new initiatives, such as our [Sail Through Summer](#) program, the certification process is easier and more transparent than ever before.

**More Business Development Assistance:** We're helping MWBEs secure state contracts and grow their businesses. Graduates of last year's DMWBD Business Growth Accelerator were awarded over \$105 million in procurement opportunities. Additionally, through a partnership with the White House called the Initiative for Inclusive Entrepreneurship, MWBEs have greater access to growth capital enabling them to participate in exciting economic development projects occurring right here in New York State.

At the 2024 State of the State, Governor Hochul shared her "Our New York, Our Future" agenda. Our New York consists of a vibrant and dynamic MWBE community where every entrepreneur has a chance to succeed regardless of race or gender. As we prepare for a new year, I would like to thank all our New York State agencies and authorities for their efforts to increase MWBE participation on state contracts. Your commitment is essential to our program and we look forward to even greater success in 2025.

## The Division of Minority and Women’s Business Development

Executive Law Article 15-A (§§ 310-318) governs requirements for the participation of minority and women-owned business enterprises (“MWBEs”) in New York State contracting. The objective of Article 15-A is to promote equality of economic opportunities for MWBEs and to eliminate barriers to their participation in state contracting.

The Division of Minority and Women’s Business Development (“DMWBD”) oversees the statewide MWBE program operated by “state agencies” (which includes, *inter alia*, state agencies and public authorities) as defined by Article 15-A. The Division is charged with three primary functions: (1) to encourage and assist state agencies that are engaged in contracting activities to award a fair share of state contracts to MWBEs; (2) to review applications by businesses seeking certification as a MWBE and to maintain a directory of certified MWBEs; and (3) to promote the business development of MWBEs through education and outreach to agencies and MWBEs.

## FY 2023-24 MWBE Statistics

The mission of the DMWBD is to promote equality of economic opportunities for Minority and Women-owned Business Enterprises (“MWBEs”) and to eliminate barriers to their participation in state contracting. Each year, the DMWBD provides a report on program progress and success which includes information on the annual New York State (NYS) MWBE utilization, overall NYS MWBE expenditure, and the total number of certified NYS MWBEs.

### NYS MWBE Utilization and Expenditure

The DMWBD is proud to announce that, for the fourth year running, NYS has **exceeded** Governor Hochul’s 30% aspirational MWBE utilization goal. New York State, the DMBWD, and NYS Agencies and Authorities continue to deliver, and exceed, on their commitment to championing greater equality of economic opportunities for MWBEs.

## *NYS MWBE Certified Firms*

With Governor Hochul’s support and additional funding, the DMWBD has been able to improve application processing times, application submission and review processes, and provide in-person support across all 10 NYS regions. Due to these improvements an applicant may expect to receive a determination on their certification application in about 90 to 120 days. DMWBD has been able to complete the review applications more efficiently, update the directory of certified MWBEs quicker, and increase the overall MWBE participation in state contracting.

### *NYS MWBE Expenditure by Industry*

During FY 2023-24, the overall NYS 15-A eligible expenditure increased by 5.39% from \$8.7B in FY 2022-23. With the overall increase in NYS 15-A eligible expenditures, NYS MWBE utilization also increased by \$144M.

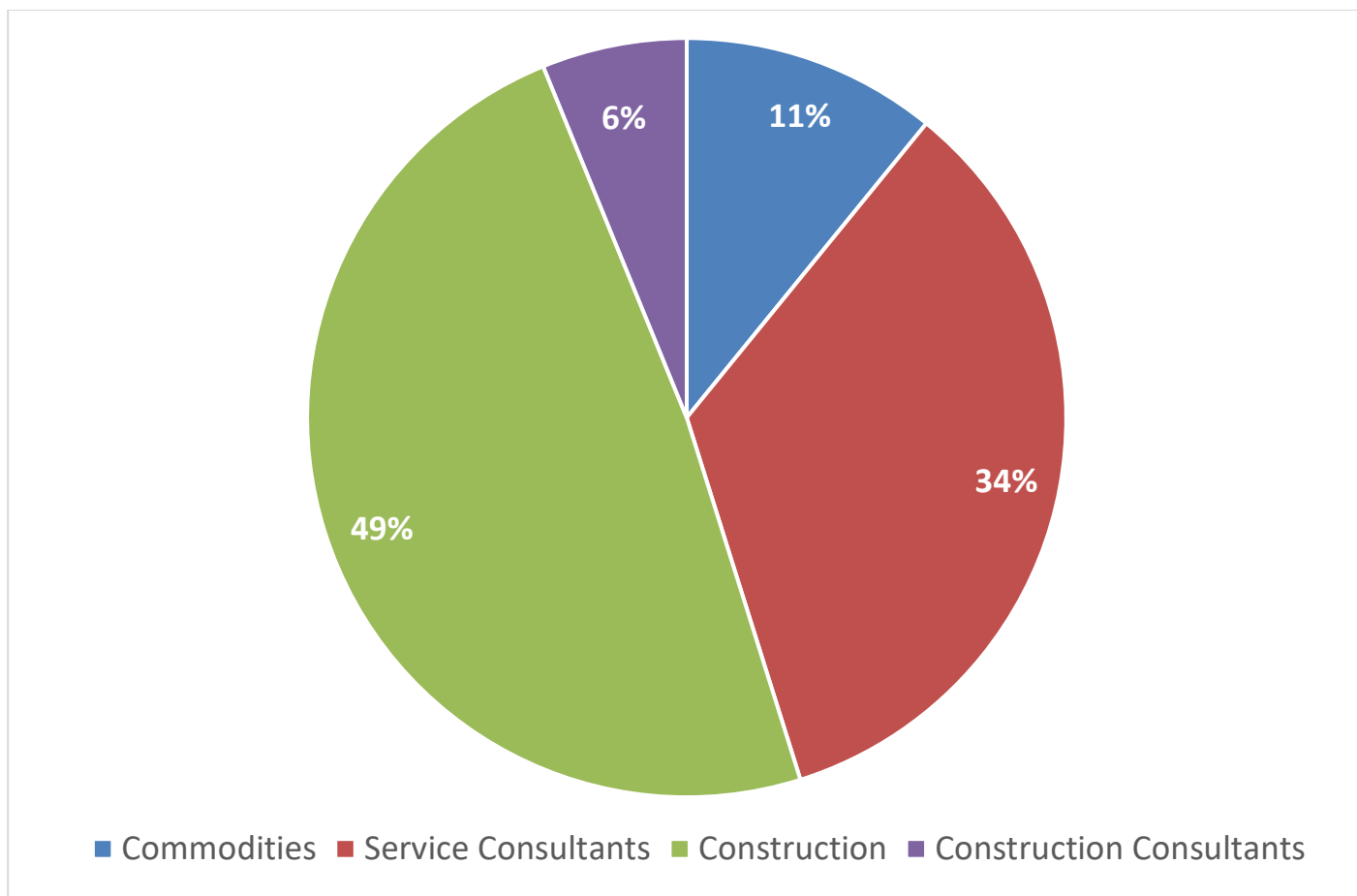

## *NYS MWBE Regional Statistics*

Increased regional engagement and support is a key component of the DMWBD's strategic plan. To that end, the DMWBD is providing a breakdown of MWBE certification and utilization by region. This information will create a more robust understanding of the current state, successes, and opportunities for improved support and service by NYS Regions. Now more than ever, the DMWBD is committed to strengthening its support for NYS MWBEs through increasing its work and presence throughout all NYS Regions.

In FY 2023-24, the DMWBD provided enhanced regional MWBE business development events and outreach, including training sessions, webinars, business growth opportunities, and programs aimed at connecting MWBEs with NYS Agencies, Authorities, and local contracting opportunities. One of the signature events was the MWBE Regional Opportunities Expo Series hosted in Western NY, New York City and Central NY which boasted over 1,000 attendees and close to 90 speakers including government representatives and subject matter experts. The expo series also provided 30 panels/workshops on various topic areas relevant to MWBEs including access to capital, how to do business with NYS, competing successfully and insights on local economic development projects. Also, the Division hosted 2 webinars per month with MWBEs as the target audience as part of the MWBE Training and Events Series. The webinars provided information and insights to MWBEs on contract opportunities, viable lending and surety bonding programs, and DMWBD led programs to help businesses thrive. Also, in FY 2023-2024, the Division attended close to 100 events in tabling and presentation capacities throughout the NYS regions to better reach and engage MWBEs.

## FY 2023-24 NYS MWBE Waivers and Violations

Waivers occur at or after the time of award of a contract and may result in a reduction or elimination of the MWBE goals that were established by the agency. Waivers may be granted following consideration and review of various regulatory factors (for example, the availability, number, or types of certified MWBEs, contract dollar value, scope of work, project size and term) as well as documented good faith efforts to meet the contract goals. Requests for partial or total waivers may be considered.

A contractor may be held liable for the willful or intentional failure to comply with MWBE program requirements; such violations may result in sanctions including monetary damages.

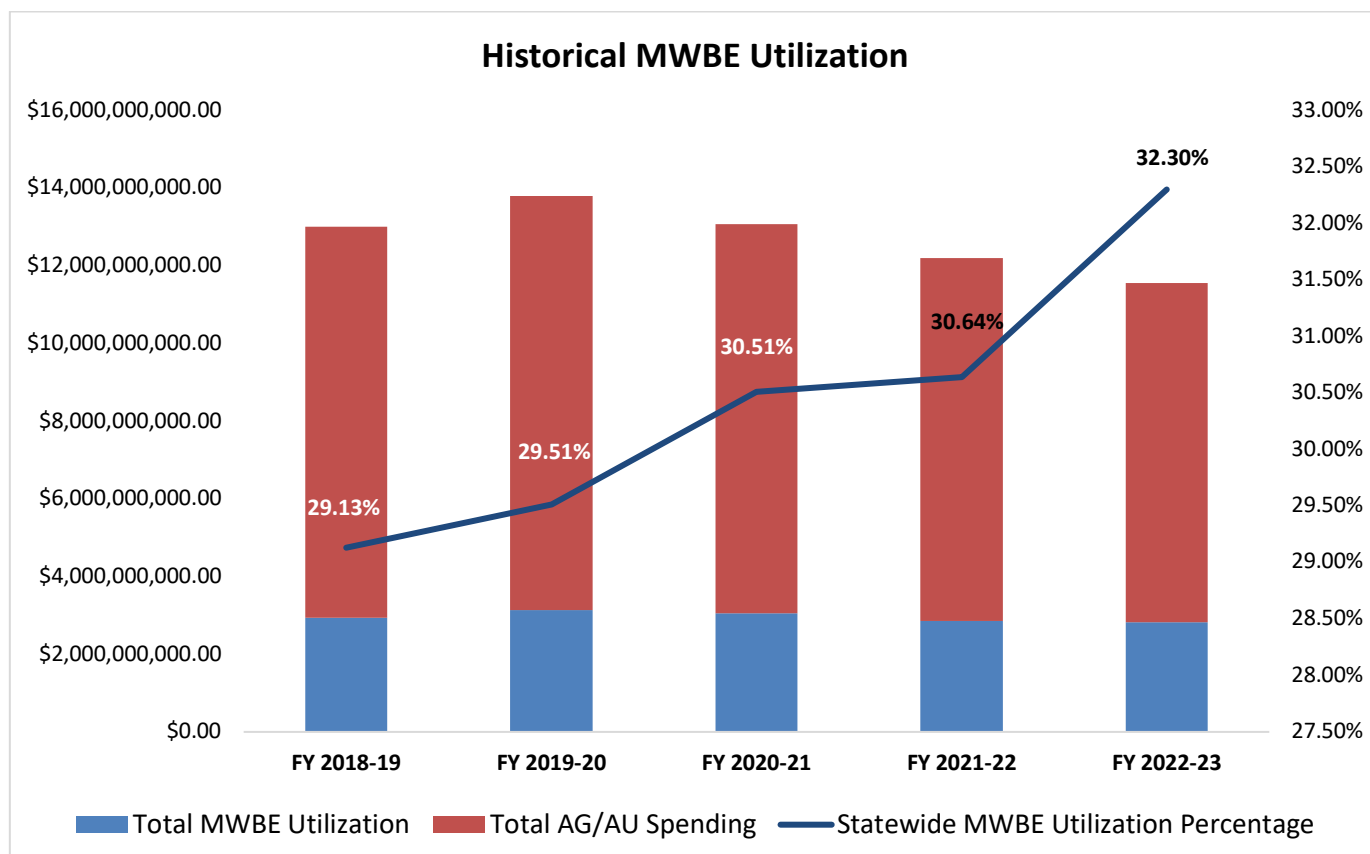

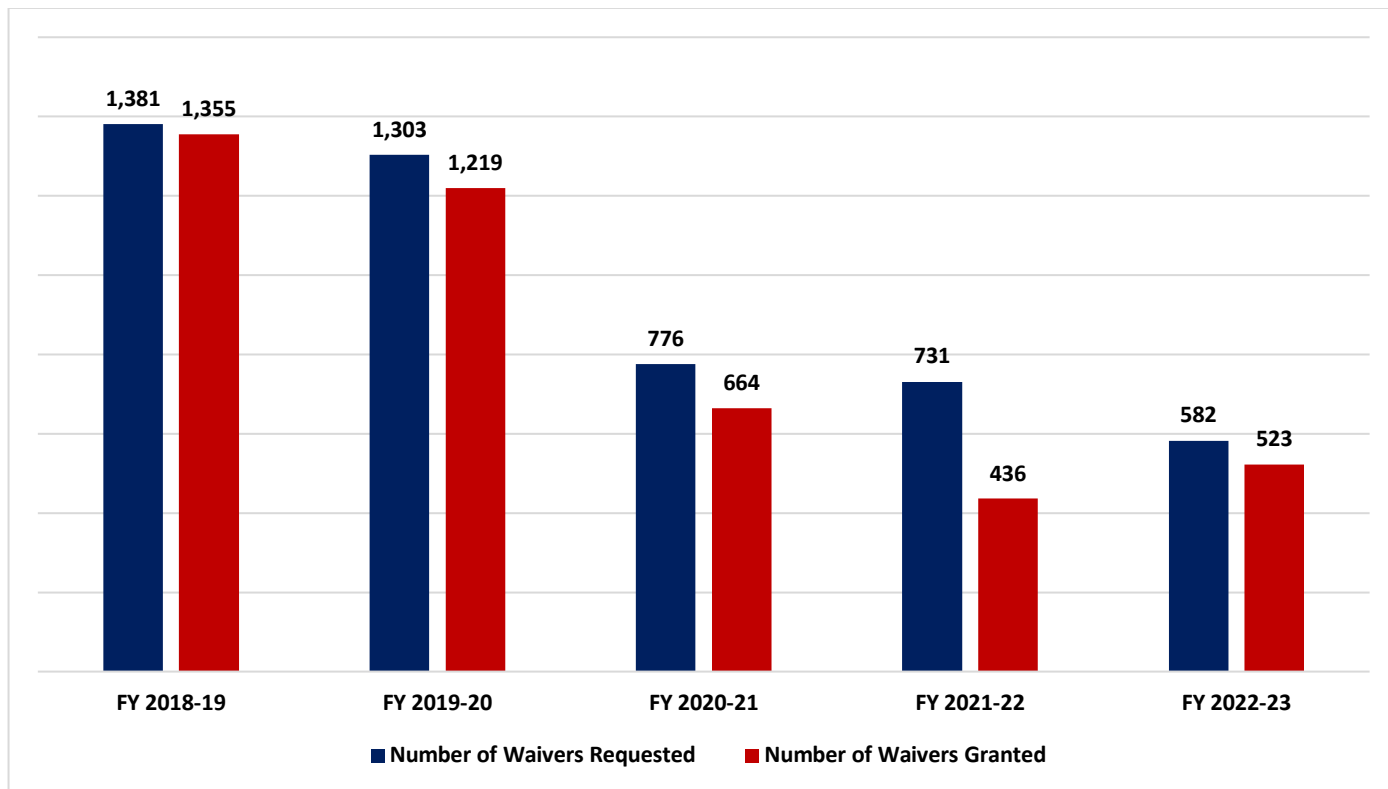
## Historical NYS MWBE Utilization and Expenditure
