

The following community-based organizations, hospitals and government agencies have received grant funding to hire or contract with case managers who can coordinate services for victims and/or their families.

Case managers will be funded for three years, with an option for a two-year renewal. Grant totals vary because grantees were eligible to apply for a maximum of \$75,000 (salary and associated fringe benefits for each manager per year) and an additional \$5,000 for each case manager per year for associated costs, such as travel and computers.
