**GOUVÈNÈ CUOMO ANONSE PLIS PASE \$6 MILYON DOLA POU EDE FOUNISÈ SANTE TIMOUN KI GEN PWOBLÈM MANTAL YO AMELYORE TEKNOLOJI ENFÒMASYON SANTE**

***Yo te bay 122 founisè preske \$50,000 chak pou renove enfrastrikti teknoloji***

Gouvènè Andrew M. Cuomo jodia te anonse prim \$6,081,700 pou ede 122 founisè sante konpòtman kap ofri timoun yo sèvis amelyore oswa devlope enfrastrikti teknolojik yo. Lajan sa, ke yo bay nan tout eta, founisè yo ap itilize yo pou enplemante nouvo teknoloji oswa mete ajou enfrastrikti bòdwo Medicaid yo.

“Administrasyon sa angaje pou bay pi bon anviwonman sante posib pou timoun yo nan eta nou an,” **te deklare Gouvènè Cuomo**. “Kòm nap transfòme epi modènize sistèm swen sante konpòtman, finansman sa ap ede founisè yo itilize teknoloji pou senplifye sèvis yo pou amelyore lavi jèn moun yo nan eta.”

Founisè yo ap itilize finansman yonsèl fwa sa pou achte amelyorasyon pou enfrastrikti teknolojik enkli dosye sante elektwonik oswa lojisyèl pou voye bòdwo, nouvo sèvè medya yo ap sipòte sistèm baz done, ansanm avèk òdinatè, woutè, ansanm avèk lòt materyèl. Yo ka itilize lajan an tou pou edike anplwaye yo sou kijan pou pi byen itilize sistèm jesyon enfòmasyon sante. Yo te atribye fon sa yo a yon total 49,850 founisè sou jiridiksyon Biwo Sante Mantal, Biwo Alkòl ak Sèvis Abi Sibstans, ak Biwo pou Moun ki gen andikap.
