Employment-Focused Services Grants

The following agencies and non-profit organizations will share \$6.4 million in funding to provide employment-focused services to parolees, probationers and individuals participating in courtordered programs.

Three of the 13 grant recipients – Center For Employment Opportunities (CEO), EAC Network, and The Osborne Association – operate programs in more than one county. As a result, they are listed multiple times:

- The Fortune Society: \$1,136,568 to serve individuals on parole.
- The Osborne Association: funding for two programs totaling \$500,000 to serve individuals on parole and probation.
- New York City Department of Probation: \$396,360 serving individuals on probation.
